

<p>Snowmobile Rules/Regulations: (Snowmobile Applicant) hereinafter called Applicant, has been issued this permit by the Forest Preserve District of Cook County (FPCC), Illinois, with the following stipulations:</p> <ol style="list-style-type: none"> 1) The Applicant shall abide by all rules and regulations set forth by the State of Illinois Snowmobile Registration & Safety Act 625ILCS 40/3-13 and any additional rules and regulations established by the FPCC. 2) The Applicant shall attach and display in a conspicuous manner on the front windshield of the snowmobile cowling the permit sticker issued by the FPCC. 3) The Applicant shall carry the permit/proof of liability insurance and the FPCC's snowmobile rules/regulation sheet on his person at all times while operating said snowmobile on FPCC property. 4) The Applicant and any Operator of a snowmobile are jointly and severally liable for any injury and/or damage caused by the operation of such snowmobile. 		
<p>Waiver Each applicant shall agree to and comply with the following "Save Harmless" clause: I shall assume entire responsibility and liability for all losses, expenses, damages, demands, judgments and claims in connection with or arising out of any injury or alleged injury (including death) or damage or alleged damage to property sustained or alleged to be sustained by anyone in connection with the Permit granted herein. The applicant further agrees to defend, indemnify and hold harmless the FPCC, its President, Commissioners, agents, servants and employees from any and all losses, expenses, damages, judgments, demands and claims and shall defend any suit or action brought against them or any of them based on any such alleged injury or damage or death, and shall pay all damages, judgments, costs and expenses, including attorney's fee, in connection therein with and resulting therefrom.</p>
